I work hard to make empirical research accessible and easy to digest. I have published in top academic journals, written for popular audiences, composed white papers for policymakers, and created data visualizations that make even the most complex phenomena meaningful. BOOK UNDER CONTRACT

Faith in Imprisonment: Religion and the Making of Mass Incarceration excavates the role of religious ideas and organizations in shaping the structures and experiences of mass incarceration. It draws on nearly two years of archival research I conducted in previously unaccessed archives, 13 months of ethnographic research I conducted in a 3,600-bed Florida prison, and more than 120 interviews with prisoners, probationers, legislators, prosecutors, judges, prison administrators, prison staff, and other policymakers. It is under contract with the University of Pennsylvania Press.
